Legal basis of the processing

This site processes data based on consent. HOLDER OF THE TREATMENT

DATA PROCESSING PLACE

The data collected by the site are processed at the data center of the soc. Affiliationsoftware that is responsible for data processing, processing them on behalf of the owner, is in the space European Economic Program and acts in accordance with European standards. Data is only handled by personnel technician of the Office in charge of processing, or by persons in charge of occasional operations of maintenance. No data deriving from the web service is communicated or disseminated. Personal data provided by users who send requests for information material (newsletters, documents, responses to queries, etc.) are used only to perform the service or provision requested and are communicated to third parties only if this is necessary for that purpose.

This site may share some of the data collected with services located outside the area of European Union. NAVIGATION DATA

Browsing this website determines the automatic activation of procedures that acquire, in during their normal operation, some personal data whose transmission is implicit in the use of the protocols of Internet communication. This is information that is not collected to be associated with certain interested parties identified, but which by their very nature could also be processed and associations with data held by third parties, allowing users to be identified. SPECIFICATION OF THE PROCESSING METHOD

SECURITY MEASURES
